APPROVE PUBLISHED AGENDA AND ALL ADDITIONS: Motion was made by Council Member Phillip Deason to approve the agenda. Motion was seconded by Council Member Linda Crowe and all present voted AYE: Motion was carried by unanimous vote.

CONSIDER APPROVING THE MINUTES OF March 14, 2016: Motion was made to approve by Council Member Ricky Parker. Motion was seconded by Council Member Lynn Taylor: Motion was carried by all except Phillip Deason and Jeff Green abstained.

Carl Carter - from Arbors Sub, to speak to Mayor and Council. Slow and bad service from Windstream.

Wayne Taylor - Consider approval for replacement of door actuator, charge A/C and replacement of wiper motor that is under warranty police car #314. Cost- \$423.99. Vendor Poe Tire & Auto. Motion was made by Ricky Parker to approve. Motion was seconded by Phillip Deason and all present voted AYE: Motion was carried by unanimous vote.

Wayne Taylor - Consider approval for body work on police car #314. Vender Simpson's Body Shop, Cost \$326.80. Motion was made by Linda Crowe to approve. Motion was seconded by Ricky Parker and all present voted AYE: Motion was carried by unanimous vote.

Mayor Lee – Consider approving clean up, spraying and prep work for the front lawn and replacing all flower beds in front of city hall, cost \$600.00. Also monthly lawn service for the front lawn and side lawns on Park Ave. at city hall that includes treating and cutting the lawn every week in the summer and growing months and every other week after that, replacing flowers and mulch twice a year, fertilize and weed control 9 times a year. Cost \$375.00 monthly. Motion was made by Jeff Green to table. Motion was seconded by Ricky Parker and all present voted AYE: Motion was carried by unanimous vote.

Mayor Lee – Consider approving a public works project to remove the fill dirt form the Civic Center site not to exceed \$25,000.00. Motion was made by Ricky Parker to approve. Motion was seconded by Phillip Deason and all present voted AYE: Motion was carried by unanimous vote.

Mike Staggs – Consider approving to purchase a new American flag for the park, cost \$289.00 from American Flag Company. Motion was made by Phillip Deason to approve. Motion was seconded by Jeff Green and all present voted AYE: Motion was carried by unanimous vote.

Linda Crowe – Consider approving to purchase a laptop computer for the Civic Center with software not to exceed \$1,800.00. Motion was made by Linda Crowe to approve. Motion was seconded by Phillip Deason and all present voted AYE: Motion was carried by unanimous vote.

Ricky Parker – Consider having the city attorney contact the property owners of the Vinny Vitoes location to start the cleanup from the fire. Motion was made by Ricky Parker to approve. Motion was seconded by Lynn Taylor and all present voted AYE: Motion was carried by unanimous vote.
