Roxanne Nichols** (HOA President of Twin Lakes) – **To address the Mayor and Council.** Roxanne Nichols addressed the Council about an accessory structure constructed within the Twin Lakes subdivision. She expressed concern as to whether the same complied with the City’s Ordinance(s) and code(s). She acknowledged the City did not enforce the subdivision’s restrictive covenants but did want the City to review the same pursuant to its applicable regulations. City Attorney James Hill advised that the City would be (and had been) reviewing the same and he would reach out to Ms. Nichols to discuss the same.
