**1. Mayor Lee - PUBLIC HEARING AND FIRST READING: 6:03pm**

**The City of Moody Planning Commission request to amend the zoning ordinance of the City of Moody, Alabama for the: *JOEL WASHINGTON REQUEST APPROVAL TO REZONE HIS PROPERTY LOCATED AT 3404 MOODY PARKWAY AND FURTHER IDENTIFIED AS TAX ID# 24-09-31-0-001-013.001 CURRENTLY ZONED AS AG-1 (AGRICULTURAL) TO B-3 (TOURIST COMMERCIAL DISTRICT).***

Any persons desiring to speak in favor of or in opposition to this request will be heard at this time and place. \* Joel Washington said would like land to be zoned B3, possible office space.

**2. Mayor Lee** – Consider approval of a Proclamation naming January 24-30, 2021 as National School Choice Week. Motion was made by Council Member Matt Morris to approve. Motion was seconded by Council Member Nick Rutledge and all present voted AYE: Motion was carried by unanimous vote.

**3. Thomas Hunt** – Consider approval for 2017 Ford Explorer 342 (Officer Weal). It needs tires \$508.00 and brakes \$180/parts \$200. Total is \$888.00 Vendor is Moody auto service. Motion was made by Council Member Lynn Taylor to approve. Motion was seconded by Council Member Ellis Key and all present voted AYE: Motion was carried by unanimous vote.

**4. Thomas Hunt** – Consider approval to spend up to \$2,500 for Office furniture. Vendor Rosewood Furniture. Budgeted item capital outlay 513-9900. Motion was made by Council Member Linda Crowe to approve. Motion was seconded by Council Member Nick Rutledge and all present voted AYE: Motion was carried by unanimous vote.

**5. Thomas Hunt** – Consider approval to pay St Clair County the annual School Resource Officers Service, cost \$7,500.00. Motion was made by Council Member Nick Rutledge to approve. Motion was seconded by Council Member Lynn Taylor and all present voted AYE: except Matt Morris abstained, Motion was carried.

**6. Larry Horton** – Consider approval to purchase of Thank You Cards. Cost- \$265.97, Vendor – Smith Printing, Budgeted – 01-514-4800. Motion was made by Council Member Lynn Taylor to approve. Motion was seconded by Council Member Matt Morris and all present voted AYE: Motion was carried by unanimous vote.

**7. Larry Horton** – Consider approval sending Inspector Mulkey to the IAAI conference in Gulf Shores. Total Cost - \$670.00, Budgeted – 01-514-1500. Motion was made by Council Member Linda Crowe to approve. Motion was seconded by Council Member Matt Morris and all present voted AYE: Motion was carried by unanimous vote.

**8. Mayor Lee** – Consider approval to enter into an agreement with St Clair County pave Church Street as follows:

- The portion of Church Street from CR-10 to Carl Morgan Rd that is considered to be County Maintained
- The portion of Church Street from Carl Morgan Rd to US Hwy 411 that is considered to be City Maintained
- The portion of the turn lane that transitions from CR-10 to Church Street that is not on the ROW for CR-10 that is considered to be County Maintained
- The County will pave Church Street from CR-10 to US Hwy 411 and the turn lane between CR-10 and Church Street using its bid in place
- The County will stripe and put in pavement markers with its bid in place
- The County will pay for the total cost to have the whole road paved and striped
- The City of Moody will accept Church Street from CR-10 to US Hwy 411 and the portion of the turn lane that transitions from CR-10 to Church Street that is not on the ROW for CR-10. for maintenance when the project is complete.

Motion was made by Council Member Nick Rutledge to table this request to gather more info on the project. Motion was seconded by Council Member Lynn Taylor and all present voted AYE: Motion was carried by unanimous vote.
