- The portion of Church Street from Carl Morgan Rd to US Hwy 411 that is considered to be City Maintained
- The portion of the turn lane that transitions from CR-10 to Church Street that is not on the ROW for CR-10 that is considered to be County Maintained
- The County will pave Church Street from CR-10 to US Hwy 411 and the turn lane between CR-10 and Church Street using its bid in place
- The County will stripe and put in pavement markers with its bid in place
- The County will pay for the total cost to have the whole road paved and striped
- The City of Moody will accept Church Street from CR-10 to US Hwy 411 and the portion of the turn lane that transitions from CR-10 to Church Street that is not on the ROW for CR-10. for maintenance when the project is complete.
